General Terms and conditions for the Exhibition of the Euro BioMAT 2017 (09.-10. May, Weimar)

The industrial exhibition of the BioMAT 2017 will take place from Tuesday 09. May 2017 to Wednesday 10. May 2017 at the Park Inn by Radisson Weimar Hotel, Kastanienallee 1, 99428 Weimar (Germany). The conference and exhibition will be organized by Deutsche Gesellschaft für Materialkunde e.V. (DGM) and INVENTUM GmbH.

For participants to the conference the program will begin on Tuesday 09. May 2017 at 08.00 AM approximately and will end on Wednesday 10. May 2017 at 17:00 PM approximately.

1. Conclusion of the contract

The contract between INVENTUM GmbH and the company is considered to be effective once the company has sent the Registration form to participate in the exhibition to INVENTUM GmbH and INVENTUM GmbH has confirmed the receipt of said Registration form. INVENTUM reserves the right to withdraw from the contract if an important reason exists, especially when the interests of the organizer are violated or the claimed floor space cannot be provided.

2. Technical and organizational conditions of participation

During the exhibition the exhibitor is subjected everywhere on the premises to the in house regulations of the venue (Park Inn by Radisson Weimar Hotel) and the corresponding specifications of the organizer. The Project Manager reserves the right to refuse an exhibitor in the interest of INVENTUM GmbH, the German Materials Society (DGM) and the conference BioMAT 2017.

The exhibitor is obliged to occupy its stand/booth and to provide personnel for it during the entire duration of the conference.

Advertising of any kind is authorised only within the area rented by the exhibitor for his own company and only for the products, which the exhibitor produces or sells.

Swapping of the assigned space with other exhibitors' spaces or partial or complete handover of the booth/stand to third parties will only be permissible through a written agreement with the organizer.

The exhibitor fee for a stand/booth of 6 square meters (minimum size) is 1,020.00 EUR excluding VAT. The cost per additional square meter is 170.00 EUR excluding VAT. Furniture, electricity and auxiliary equipment can be provided upon request for an additional charge.

Those requirements can be requested from INVENTUM GmbH and shall be communicated not later than 30. March 2017. Stand/booth equipment must be provided by each exhibitor himself/herself.

The assignment of the exhibition spaces will be made by INVENTUM GmbH in consultation with the exhibitors. The exact booth plan with the stand location, stand number and the general information on the assembly and disassembly conditions will be sent after the preparation of the entire exhibition schedule about four weeks before the meeting.

Setup and assembling of the stand/booth is possible on 08. May 2017 from 18.00-20.00 PM and on 09. May 2017 from 07.00 – 09.30 AM. The dismantling of stands/booths and removal of exhibits takes place after the end of the scientific program on 10. May 2017 and shall be organized by the exhibitor. It is possible to drive by car directly to the venue to deliver or pick up equipment. Please inform INVENTUM GmbH of the desired setup time not later than 15. April 2017.

3. Internet Connection

A WiFi internet connection will be made available for a fee by the Park Inn by Radisson Weimar Hotel and can be purchased on site at the reception.

4. Terms of Payment

All prices are quoted before Value Added Tax (VAT).

After registration, the exhibitor will receive a payment invoice amounting to 25% of the total costs. The final invoice will be issued after the meeting. The invoice amount must be payable to the bank account indicated on the invoice within 14 days.

5. Cancellation / Withdrawal

The following cancellation charges plus VAT will be invoiced:

Cancellation until 01. March 2017 - 50% of the total amount.

Cancellation after the 02. March 2017 - 100% of the total amount.

Special arrangements cannot be made on grounds of obligation to third parties.

5. Liability

The exhibitor is liable for all damages caused by himself, his staff, his representatives or his visitors. The organizer of the meeting shall have no liability for damages, which have not occurred due to intent or gross negligence by the organizers, its agents and staff. This excludes damages in the form of injury to life, body and health as well as those, which are caused by violation of cardinal obligations.

6. Place of performance and place of jurisdiction

The place of exercise and jurisdiction for all disputes arising from this contract shall be Frankfurt am Main.
